



## **ELIGIBILITY REQUIREMENTS**

When auditioning at one of the audition venues in South Africa, please prepare the following:

- Groups can only have a maximum of 5 members.
- Up to three (3) vocal performances each no longer than three (3) minutes. (Groups might not perform all songs but should be prepared).
- Two (2) songs must be recognizable commercial cover songs.
- Medleys are allowed but should be no longer than three (3) minutes.
- ALL musical styles are accepted.
- Choreography, creativity, and dress are encouraged to enhance your performance.
- NO Instruments and backing tracks are allowed.
- Microphones will be provided at open call auditions.

NB: Each member must bring a copy of a valid ID with a completed show application:

This application is for consideration to be a participant in a reality-based talent competition television series being produced by AMPN (Pty) Ltd ("Producer"). Please be advised that you must meet the following eligibility requirements (which may be changed at any time by Producer in its sole discretion) in order to participate in the Programme:

- 1. You must be 18 years of age by 30<sup>th</sup> November 2014 or older (Producer may modify the age limit at any time in its sole discretion).
- 2. You must be legally present in the Republic of South Africa and live in the Republic of South Africa. Proof of such eligibility must be provided to Producer. Acceptable forms of proof include (without limitation) a valid South African passport, South African driver's license or a South African identity document.
- 3. You will need to be available to the production on various dates to be determined by Producer in its sole discretion (dates subject to change in Producer's sole discretion) and be willing to travel to one or more locations, including Johannesburg, South Africa, as part of production. You may also need to be available on additional dates to be determined by Producer in its sole discretion for reshoots, publicity activities, etc.
- 4. You must be willing to travel at your own expense to audition for the competition as per dates provided by the Producer. All travel expenses will be the applicant's sole expense.
- 5. Any offer to become a participant shall be conditioned upon your submission to a background check, in accordance with applicable laws.
- 6. If invited by Producer to proceed as an applicant, you must timely complete and return the Participant Agreement and Release forms that will be furnished to you by the Producer.
- 7. If you are selected as a participant, you must be willing to travel to and reside at one or more undisclosed locations in Johannesburg for approximately three weeks between 19 April and 19 May 2015, and to return for one week for the final in July 2015 which will be through economy travel to be paid for by Producer. In addition, you must be available to participate in publicity activities if requested, as well as on such other days as Producer may require, including attending and participating in all preliminary interviews, rehearsals, conferences, interviews, publicity sessions and costume, hair and make-up appointments, until the completion of your participation in the Programme as required by Producer. You understand that these dates may change in Producer's sole discretion.
- 8. The foregoing eligibility requirements may be amended, revised or changed at any time and in any fashion in Producer's sole discretion.
- 9. I hereby acknowledge that (i) I have read, and I agree to be bound by the Eligibility Requirements; (ii) I have answered the previous questions honestly, accurately and without omission; (iii) I am giving Producer the express permission to contact any individual or organization which I have listed in the application as a reference for information about me; (iv) if any of the above information is found to be false, inaccurate, misleading or incomplete, I understand this will be grounds for my dismissal from the Program's participant selection process and/or from the Programme itself, if selected; (v) even if I meet the Eligibility Requirements, Producer is not obligated to interview me and/or select me as a participant; (vi) even if I am selected as a participant, Producer is not obligated to actually produce the Program and any television network broadcasting the Program is not obligated to actually broadcast it, even if produced and (vii) all decisions by Producer concerning the selection of the participants are final and not subject to challenge or appeal.
- 10. I furthermore understand, agree and give consent to both the Producer and applicable broadcaster to use my image rights and recorded audition footage for the production and broadcasting of the series.





11. I understand and agree that both the Producer and the broadcaster are entitled to make alterations to the format and/or production, whenever required.

Finally, irrespective of the outcome of the auditions and/or the decisions made by the Producer and it selection team, I understand and agree that I have no rights to any (financial) claims and/or compensation to both the Producer and broadcaster.
