DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

SABC Western Cape region office, which is based in Sea Point requires the services of suitable qualified service provider to service and maintenance of Vimec V74 paraplegic lift which used by both staff and external people, so it is therefore important to ensure that the lift is always operational and working at optimal levels.

The successful company must demonstrate its capability and experience with regards to the following:

- Extensive experience and knowledge in the Electrical engineering industry.
- Compliance with the Electrical engineering industry.
- Ability to react to emergency repair calls.

2. OBJECTIVES

The Works for this Contract comprises the servicing and maintenance.

The Works in general comprises the provision of maintenance services including:

- Provision of all labour, material, tools, machinery, equipment, supplies, transportation.
- Carrying out maintenance and repairs to the existing paraplegic lift.

3. REQUIREMENTS AND SCOPE OF SERVICES

The servicing and maintenance of the lift must be done in line with the OHS Act and cover the following:

Service and Maintenance

No.	MAINTENANCE INSTRUCTIONS
1.	Monthly Preventative Maintenance Services.
2	Basic and major safety machine inspections.
3.	Inspections, adjustments, lubrication, testing.
4.	Annexure B (every 2 years).
6.	Repair or replacement of components – to be quoted separately.
7.	Emergency callouts in the event of any breakdown.

The following guidelines for the monthly service of the paraplegic lift must be used:

Visual inspection of the lift:

- Visually inspect the unit, tracks, carriage, covers, panels and screws
- Move the lift to the upper station and check movement, controls and lift performance
- Check that the CTE plate, emergency telephone plate and unit number plate is present
- Check that the load plate is present and legible

Platform/Carriage:

- Verify condition and test emergency stop switch
- Verify condition and test key switch
- Check all indicators and displays for proper operation
- Check all buttons and controls in both directions for proper operation
- Check all moving parts for proper operation and timing
- Check associated equipment such as hydraulic filters, mini motors and limits
- Check all safety switches (external)
- Remove cover and cover panels
- Check all electrical components including pc boards, switchgear, wiring and terminals
- Check all sensors and limit switches (internal)
- Clean and lubricate rollers and sprockets, check for wear
- Check slide contacts/charge points for wear and continuity

Rail:

- Check rail brackets, mountings and fasteners
- Check clearances from nearest striking points
- Check wear and tear, lubricate lightly with oil or aerosol type lubricants
- Check charge stations for correct trickle voltage, continuity and correct position
- Check rail joins for correct alignment and clean

Batteries (if any):

- Check battery terminals and connections
- Check for correct voltages according to the specifications
- Check in-line holder and fuse (if applicable)

Motor and Brakes:

- Check motor mountings
- Check for unusual noises and vibration
- Check motor brushes
- Check motor and connections
- Check drive chain and sprocket (if applicable)
- Check brake mountings and pad wear, clean out any brake residue
- Check brake slide. Note - slide should be minimal

Controller:

- Check that all documentation is present and up to date
- Update the record book with the list of completed tasks and sign off
- Test incoming supply voltages
- Test and verify output voltages. e.g. transformers, power supplies
- Check if fuses and circuit breakers are correctly rated
- Tighten all connections and check operation of contactors, relays, auxiliaries
- Clean out controller and lock security when done

Remote Controls/Control Stations

- Check all remote and control stations for proper operation and range
- Check all functions
- Check batteries and replace if under powered
- Check all remote key switches

Overspeed Devices:

- Test and verify proper operation of the overspeed device
- Check for any wear and tear
- Test the electrical or electronic device associated with the overspeed device

Reporting:

- Submit full report on service and findings/red flags
- Discuss action plan for outstanding items
- Logistics Manager or Building Supervisor to sign documentation

Maintenance Management:

Preventative Maintenance

All preventative maintenance work shall be scheduled by the SABC or its authorized representative and communicated to the Contractor. When the maintenance is due the authorized SABC representative will issue a job card to the contractor and together shall perform the necessary planning and preparations for the successful execution of the work. Work should be scheduled in a manner so as not to interfere with any normal operations of SABC. On completion of work, the SABC representative and the contractor shall inspect the work and if both parties are satisfied with the work, both shall sign off the job card and the maintenance reports. The appointed service provider will be required to work and cooperate with other contractors on site whenever it is necessary for the purpose of installation, maintenance, faulty findings and repairs.

Normal operational hours on site shall be from 08:00 to 16:30 for every working day, Monday to Friday. No planned maintenance work will be allowed to be performed on Weekends or Public holidays unless prior approval is received from the SABC or authorized representative.

Response Time:

Response time shall be measured as the time taken from reporting the call, to the time taken by the artisan to arrive at the relevant piece of equipment.

The response to call outs shall be categorized according to the need for urgency in attending to the call out. All breakdowns during and after working hours shall be responded to as follows:

(a) Emergency Response

This shall be defined as an event that requires an immediate response or action to prevent and or mitigate equipment damage, harm or injury to people or property or to limit the disruption of services. The Contractor shall respond to an emergency call-out within 2hour.

(b) Urgent Response

This shall mean any failure or repair requirement that could significantly affect the services or pose a danger if left unattended for a long time. The Contractor shall respond to an urgent call-out within 4 hours.

(c) Routine Response

This shall apply to other failures or repairs other than those requiring emergency and urgent responses. These items shall be dealt with as unscheduled additional work items as requested by the SABC or authorized representative.

Any breakdown impacting on operations shall be attended to until restored to good reliable condition. This implies that no breakdown may be left unattended or incomplete for the next day. SABC will hold the Contractor liable for any costs incurred due to negligence or unreasonable poor performance by the Contractor including excessive time taken to effect repairs.

Modifications/ Improvement Process:

Contractors shall assume the costs incurred by SABC due to defective supplies, services or product liability issues.

Any change to the original service or product design must be approved by SABC prior to implementation.

A Request for Change must be submitted to SABC and approved before implementing it.

The Contractor shall keep records of all requests and corresponding SABC approvals.

Performance Management:

Once deliveries of the component, system, or service have been initiated, SABC will monitor the Contractor's performance to establish a trend of Continuous Improvement.

Quality of service or material and On-Time Delivery shall be the minimum metrics to be tracked for Contractor performance.

Resolution of non-conformances in the service to SABC will be addressed in a manner that will best support SABC 's standard requirements.

Expenses associated with Contractor non-conformances will be the responsibility of the Contractor.

Key Performance Indicators:

SABC will monitor Contractor's performance and report on it regularly.

Contractor's Performance Indicators are as follows:

- (a) Service Quality: % defect free deliveries received
- (b) On-time delivery: % of complete service delivery and on time, based on agreed standards.
- (c) Adherence to agreed response times

Contractors are expected to work with SABC to improve performance and/or process capability where needed.

In case of repeated poor performance or failure to improve, the contract shall be terminated.

Containment of Non-Conformity Supply of Service:

In the event a non-conforming material, component, system, or service is detected, SABC or its authorized representative will determine the best method of securing conformity to meet SABC's requirements such as:

- (a) Return the entire lot of non-conforming material, component or systems to Contractor.
- (b) Contractor to sort/rework/repair the non-conformance at SABC sites.
- (c) SABC to identify an external resource (certified by SABC to perform, sort/rework/repair at the cost of the Contractor).

Cost Recovery:

Contractors shall assume the costs incurred by SABC due to defective supplies, services or product liability issues.

Damage caused by contractor activities or employees shall be for the contractor's account.

Key Personnel:

A schedule of key personnel to this Contract (as per the Schedules) will be provided to the Authorised SABC Representative at commencement of this Contract. This will, as a minimum, include all persons to management level. For the full duration of this Contract, none of these persons will be replaced by a person of lesser ability or qualification. All on-site staff leaves shall be reported and agreed with the Engineer. The Authorized SABC Representative may request the replacement of any person with unsatisfactory performance or who fails to comply with this contract.

Management of Meetings:

The Contractor will attend meetings relating to maintenance, operations, contract management and other issues that may arise from time to time. As far as is practicable, the Contractor will make all required persons available for these meetings. The Contractor shall not submit claims for payment for staff attending any of these meetings.

Communication:

Work instructions, monthly maintenance reports, breakdown reports, etc. will all be in a format as agreed with the Authorized SABC Representative.

Health, Safety and the Environment:

The appointed service provider shall comply with SABC's Health and Safety Systems.

All persons on company premises shall obey all health and safety rules, procedures and practices. NO SMOKING signs and the prohibition of the carrying of smoking materials in designated areas shall always be obeyed.

The Contractor shall be fully responsible for compliance to the Occupational Health and Safety Act and any other relevant regulations and legislations .for all persons and equipment relating to this Contract.

Any work involving open flames sparks, cutting or heat shall be authorised by the issue of a permit to work - obtainable from the Safety department. Any work done under the protection of a permit to work shall be in strict compliance with every prescription regarding the permit.

Safety equipment shall be used where applicable (e.g. safety goggles, boots, harness, etc.) The Contractor, at his/her own expense shall provide such equipment, for his/her employees. The Contractor shall apply the necessary discipline and control to ensure compliance by his workers.

All Contractors must ensure that his/her employees are familiar with the existing emergency procedures and must co-operate in any drills or exercises, which might be held. Emergency / fire equipment and extinguishers shall not be obstructed at any time.

No person shall perform an unsafe / unhealthy act or operation whilst on Company premises.

No unsafe/dangerous equipment or tools may be brought onto or used on Company premises. The Company reserves the right to inspect all equipment/tools at any time and to prevent/prohibit their use, without any penalty to the Company and without affecting the terms of the Contract in any way.

Submission of the safety file: No document is required at the tendering stage. However, the safety file component should be factored in the pricing schedule to be submitted in response to the RFQ, as the preferred service provider will be required to furnish a copy of the file prior to commencing with the work.

4. RFQ Validity period

This bid will remain valid **90 (ninety) days** from the date of closing.

5. Costing

6. Duration of the Contract

The duration of the contract is Five (5) years.

7. Location

12. ADJUDICATION USING A POINT SYSTEM

- The bidder obtaining the highest number of total points will be awarded the contract.
- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

13. Objective Criteria

- The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within 24 months after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 24 (twenty-four) months has expired.
- Should the employee be dismissed from the SABC employment, such employee shall be prohibited from conducting business with SABC for a period of 5 (five) years from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of 24 (twenty-four) months has expired.
- Should the Board member be found guilty in a court of law due to criminal conduct/act, such Board member will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

- The SABC shall not procure any goods, services, works or Content from any independent contractor or independent contractor owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the Independent Contractor no longer be contracted to the SABC but become directors of other companies, the SABC shall not conduct business with those companies until the cooling-off period of 24 (twenty-four) months has expired.
- Should the Independent Contract be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

14. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

15. CONDITIONS TO BE OBSERVED WHEN TENDERING

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- **The Corporation reserves the right to:**
 - Not evaluate and award submissions that do not comply with this tender document.
 - Select solely on the information received in the submissions
 - Enter negotiations with any one or more of preferred bidder(s) based on the criteria specified in this tender's evaluation.
 - Contact any bidder during the evaluation process to clarify any information without informing other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
 - Award a contract to one or more bidder(s).
 - Accept any tender in part or full at its own discretion.
 - Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen based on the greatest benefit to the Corporation and not necessarily based on the lowest costs, aligned to the BEE & Price.

16. Cost of Bidding

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

a) The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
